ORDER

The University had invited application for Continuation of Provisional Affiliation for the academic year 2024-25 vide read paper (1) above. Accordingly, Principals of the Pharmacy Colleges applied for Continuation of Provisional Affiliation for the academic year 2024-25.

2) As per clause II (5) of the inspection ordinance of the University, "*inspection for granting continuation of provisional affiliation will be conducted every year till the first batch of the courses/enhanced seats in that institution is passed out. After that, inspection will generally be conducted once in two years provided the previous year's inspection report is satisfactory without any deficiencies.*"

3) Accordingly, 12 Pharmacy Colleges listed below satisfies the above conditions for granting Continuation of Provisional Affiliation for the academic year 2024-25 without conducting inspection in the College, which is detailed below:

4) The 77th Governing Council vide paper read (2) above, resolved to grant Continuation of Provisional Affiliation to the 12 Pharmacy colleges for conducting the courses with intake as detailed in above table, during the academic year 2024-25, without conducting inspection.

In the circumstances, sanction is hereby accorded to grant Continuation of Provisional Affiliation to the 12 Pharmacy Colleges mentioned in above table for conducting the courses with intake as detailed against each for the academic year 2024-25, without conducting inspection subject to the approval of the Pharmacy Council of India and that if the intake is reduced the council, the same shall prevail.

The College shall strictly adhere to the following conditions:

- i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
- ii) In the light of the direction of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iii) Affiliation granted is strictly Provisional and only for the academic year 2024-25. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- iv) Admission to the next academic year shall be made only after obtaining prior permission from the University.
- v) College has to remit annual administration fee fixed for UG/PG Courses during 2024-25.
- vi) The colleges should submit approval order from PCI for the year 2024- 25.
